Wyoming Occupational Fatalities Rise in 2007

Wyoming occupational fatalities rose by 12, from 36 in 2006 to 48 in 2007, an increase of 33.3% (see Figure), a level of incidence more in line with those from 2004 and 2005. The higher fatality count was the result of an increase in transportation accidents, particularly non-highway accidents and aircraft accidents (see Table 1). In these categories in 2006 there were an insufficient number of fatalities to be statistically reportable. In 2007, however, non-highway accidents accounted for 4 deaths, while aircraft accidents yielded 6 fatalities. Despite increases in transportation accidents overall, highway accidents involving collisions between vehicles or mobile equipment fell by 5 from 2006 to 2007.

On an industry basis, both Agriculture, Forestry, Fishing & Hunting and Construction added three fatalities, respectively, over the prior year. No industry experienced a decline in total fatalities, with all major industries adding at least one fatality since 2006. However, the subsector of Mining and Transportation & Warehousing (a subsector of Trade, Transportation & Utilities) had no net increase or decrease.

Variations in fatalities from year to year are, to some extent, the result of the random nature of work-related accidents. This is especially true when several single work-related accidents in one year yield multiple deaths, as was the case in 2007 when three unique events resulted in seven deaths. The consequence is a higher number of fatalities compared to the number of events. The only events that show a consistent pattern in Wyoming are transportation events, highway accidents in particular. Other events show less consistency from one year to the next. 


Figure: Wyoming Occupational Fatalities, 1993-2007
