Wyoming Growing and Declining Industries Report, 2021Q1 by: Michael Moore, Editor

A growing or declining industry is defined as an industry's employment level increasing or decreasing for two quarters by 5% or more over the year. For example, all industries that grew or declined in employment by at least 5% from 2019Q4 to 2020Q4 and subsequently from 2020Q1 to 2021Q1 were included in the respective tables in this report.

Industries are defined by the North American Industry Classification System (NAICS). For this research, growing and declining industries are determined at the three-digit subsector level. For more information on NAICS, please see http:// www.census.gov/epcd/www/naics.html.

The database used to generate this information was the Quarterly Census of Employment and Wages (QCEW) file, which has roughly a half-year time lag from the distribution of this report. Every quarter, when new QCEW data become available, growing and declining industry information is updated. Only subsector employment sizes of 100 or more are included in these lists. Consequently, while employment in other industries may meet the growth criteria, that growth is taking place in industries with employment of less than 100.

For example, on the growing industry table (see Table 1, page 4), the average monthly employment for food & beverage stores (NAICS 445) grew by 5.2% (244 jobs) over the year in 2021Q1 and 5.5% (262 jobs) in 2020Q4, thus qualifying as a growing industry for 2021Q1. The average growth rate for 2020Q4 and 2021Q1 for

NAICS 445 was 5.3%. Other growing industries included food manufacturing (NAICS 311; 17.2%), primary metal manufacturing (NAICS 331; 7.6%), building material & garden supply stores (NAICS 444; 7.6%), and couriers & messengers (NAICS 492; 17.9%). A feature article on couriers & messengers is presented on page 9 of this publication.





Figure 1: Distribution of Growing and Declining Industries (NAICS 3-Digit Subsector) in Wyoming, 2021Q1

Overall, Wyoming had seven growing industries in 2021Q1, which accounted for 8.2% of all industries and 5.6% of total employment (see Table 3 and Figure 1, page 8).

The declining industry table (see Table 2, page 5) reads the same way, except with negative changes, and therefore, declining industries. There were 24 declining industries in 2021Q1, which made up 28.3% of all industries and 19.4% of the state's total employment. Declining industries included support activities for mining (NAICS 213; -4,066 jobs in 2021Q1, with an average rate of change of -49.2%), heavy & civil engineering construction (NAICS 237; -2,287 jobs in 2021Q1, with an average rate of change of -32.7%), and accommodation (NAICS 721; -1,882 jobs in 2021Q1, with an average rate of change of -18.2%).

The average weekly wage is calculated by

dividing the total wage for the industry group by the total number of jobs for the industry group and number of weeks in the observed quarter. In 2021Q1, the average weekly wage was \$695 for growing industries and \$1,196 for declining industries (see Table 3 and Figure 2, page 8). Overall, the state's average weekly wage was \$951.

Growing Industry Spotlight: Couriers & Messengers (NAICS 492) by: Carol Toups, Senior Statistician

Excerpted from Wyoming Labor Force Trends, July 2021.

The industry subsector titled "couriers & messengers," which is given the North American Industry Classification System (NAICS) code 492, is listed in this report as a growing industry in Wyoming (see page 3 for definitions). The full article is available in the July 2021 issue of *Wyoming Labor Force Trends* online at https://doe.state.wy.us/LMI/ trends/0721/0721.pdf#page=16.

Some business activities included in this group are air courier services, courier services, express delivery services, local letter & parcel delivery services, and letters, documents, & small parcels local delivery services. The numbers discussed in this article are for private industry and thus, the U.S. Postal Service is not included in this industry group.

Statewide Wyoming quarterly data included in this article are total payroll, average monthly number of employees, average weekly wage, and number of businesses. Information presented in this overview was obtained from the quarterly Wyoming Unemployment Insurance reports and compiled by the Quarterly Census of Employment and Wages (QCEW) program, which is administered by the Research & Planning (R&P) section of the Wyoming Department of Workforce Services. The data discussed in this article are available online at https://doe.state. wy.us/LMI/toc_202.htm.

During the period from second quarter 2002 (2002Q2) to second quarter 2020 (2020Q2), nearly all of the periods reviewed showed increased payroll each year, based on data from the Quarterly Census of Employment and Wages (QCEW). The highest over-the-year growth in payroll during this time was seen in 2014Q2 (\$1.0 million, or 12.2%), 2020Q2 (\$746,504, or 6.5%), and 2019Q2 (\$718,185, or 6.6%).

Overall, from 2000Q2 to 2020Q2, total payroll rose from approximately \$5.2 million to almost \$12.3 million, which was an increase of just over \$7.0 million, or 136.1%.

There were 14 periods in which the average monthly number of employees increased, while five periods showed slightly declining employment numbers. One quarter (2011Q2) did not see any change. The greatest over-the-year increases in employment were seen in 2020Q2 (97, or 9.7%) and 2014Q2 (64, or 8.0%).

In summary, from 2000Q2 to 2020Q2, the average number of monthly employees rose from 671 to 1,102 (431, or 64.2%).

Of the 20 periods reviewed for changes, six showed losses in average weekly wage. The largest reduction occurred during 2015Q2 (-\$47, or -5.5%). The other 14 periods all showed increasing average weekly wages, with the highest increase in 2006Q2 (\$52, or 7.5%).

Couriers & messengers showed an average weekly wage of \$596 for 2000Q2 and by 2020Q2 this had grown to \$857, a gain of \$261, or 43.8%.

The number of businesses covered by Unemployment Insurance increased from 46 in 2000Q2 to 63 in 2020Q2, a gain of 17 (37.0%) locations during the 20-year period. This publicaton was produced by the Research & Planning section of the Wyoming Department of Workforce Services.
