Initial Claims Increase in All Industries




Figure 1: Total Number of Initial Unemployment Insurance Claims for Wyoming by Year and Month, January 2009 to November 2019

here were 2,715 initial Unemployment Insurance (UI) claims in November 2019, a 28.0% increase compared to November 2018. Initial claims increased in all industry sectors and most counties. Figure 1 shows the trend in initial claims from 2009 to 2019.

Initial Claims

Over the year, initial claims rose from 2,121 to 2,715, an increase of 594 claims, or 28.0%. The greatest increases were seen in construction (150 claims, or 22.5%), mining (127, or 201.6%), and trade, transportation, warehousing, & utilities (70, or 38.7%). Government claims increased by 73 (39.7%), led by federal government (44, or 36.1%). See Table 1 (page 4) and Figure 2 (page 5).





Figure 3: Initial Unemployment Insurance Claims by County of Residence, November 2019

Initial claims were up in 18 counties, with large increases seen in Sublette (106.3%, or 18 claims), Converse (105.6%, or 21 claims), and Sweetwater (88.6%, or 84 claims) counties. Initial claims for out-ofstate claimants increased from 461 to 641 (180 claims, or 39.0%). See Figure 3 (page 5).

Continued Claims

Total continued weeks claimed increased from 10,644 to 11,878 (1,234 weeks, or 11.6%). The number of unique claimants grew from 3,354 to 3,850 (496 individuals, or 14.8%) while the number of benefit exhaustees decreased from 390 to 348 (-42 claimants, or -10.8%). See Table 2 (page 6).

Over-the-year increases in continued claims were seen in most goods-producing industries, including construction (631, or 40.6%), mining (515, or 100.8%), and manufacturing (138 or 54.3%). Continued claims decreased in most service-providing industries, most notably leisure & hospitality (-726, or -21.7%). See Table 2 (page 6) and Figure 4 (page 7).





Figure 5: Continued Unemployment Insurance Claims by County of Residence, November 2019

Over-the-year increases were seen in 13 counties, including Natrona (392, or 33.8%), Sweetwater (318, or 59.0%), and Laramie (110, or 9.9%) counties. Continued claims for out-of-state claimants increased by 294 weeks (11.0%). See Figure 5 (page 7) and Table 3 (page 8).

Figure 2: Initial Unemployment Insurance Claims by Major Industry, November 2019

Figure 4: Continued Unemployment Insurance Claims by Major Industry, November 2019
